IMPORTANT FACTS ABOUT THE MEET:

- The 2014 Guayaquil Open Para- Swimming is a Long Course competition (50m), officially approved by the IPC.
- This meet is open to swimmers with an Intellectual disability from all nations.
- It is the responsibility of each nation to ensure they have the proper documentation to enter the ECUADOR.
- The event will be run in accordance with IPC Swimming Rules and Regulations 2011- 2014. The event has the technical endorsement of the Ecuadorian Federation of Swimming FENA.
- In case of illness local medical services are available and the event will be attended by medical support.

FACILITY:

The competition pool is an outdoor, eight lane 50 meter pool which is completely accessible. Eight lanes will be used for competition.

There is a separate outdoor, six lane 25 meter warm up and warm down pool.

ACCOMMODATION & MEALS:

The local organizing committee (LOC) will be responsible for accommodation, meals and transportation from airport to hotel and vice versa and from the hotel to the pool for teams or individuals.

Accommodation will be at the Hotel Gallery Man Ging in twin rooms <https://www.hotelgaleriamanging.com/>

Meals included are from evening meal on Tuesday 03rd through to breakfast on Monday 09th June, 2014.

CURRENCY:

The local currency is dollars USA (USD\$).

SWIMMERS ELIGIBILITY:

All swimmers with an Intellectual disability are welcome.

To be eligible swimmers must:

- Must appear on the Inas Classification Master List no later than the final entry deadline;
- Hold an active IPC Swimming license for the 2014 Season;

Seeding will be based upon time, regardless of classification.

It is the responsibility of each nation to ensure that the swimmers have the proper accreditation to enter the Ecuador.

CLASSIFICATION INFORMATION:

Classification is a two part process for the athlete with an intellectual disability.



Part 1 is to complete an Inas eligibility assessment.

Part 2 will be a sport- specific classification evaluation.

The IPC Swimming Classification Rules and Regulation (May 2011 version) apply.

Only athletes that are licensed and classified by IPC Swimming will have their results recognized for IPC Swimming rankings.

Athletes wishing to attend classification:

- Must be on the Inas classification Master List until 25 April, 2014.
- Must submit the IPC Swimming TSAL-Q questionnaire to IPC Swimming/ IPC Athletics until 28 April, 2014.
- Must be licensed until 30 April, 2014 (contact IPC Swimming/ IPC Athletics)
- Must be send classification requests directly to IPC Swimming until 30 April, 2014.
- Swimmers who undergo classification have to enter at least one **S** **and** one **SB** events. (200m. freestyle **and/ or** 100m. backstroke **and** 100m. breaststroke)

All athletes scheduled for classification must arrive for the identified date and time for classification. Federations must plan their arrival accordingly.

Classification will be conducted on Wednesday, June 04, and Thursday, June 05, 2014.

S14 swimmers with N and R status must undergo sport specific testing on site.

FORMAT:

- ✓ The meet will consist of three timed final sessions.

AWARDS:

The medals will be awarded to winners of first, second and third in each event.

ENTRY INFORMATION:

- ✓ Swimmers may enter a MAXIMUM of 4 events per session.
- ✓ Entry times must be submitted in the course swum (LCM, SCM, SCY) and will be converted by meet management for seeding purposes.
- ✓ Proof-of-Time is required with entry submission.
- ✓ No deck entries will be accepted.



ENTRY DEADLINE:

All entries must be **received** by 25/APRIL/2014

ENTRY FEE:

The entry fee is USD\$400 per person including 6 nights full board accommodation on double occupancy basis, transport, entry to the competition, social program for all members of the delegation.

Extra costs:

- Extra nights accommodation \$100USD per person per night (including breakfast)

Payment should be made in dollars USA. You are responsible for paying all bank charges/transfer fees.

ACCREDITATION:

Accreditation cards will be issued to each athlete only after he/she has personally shown his/her valid passport to the Event Eligibility Officer. Accreditation will also be provided to staff and other officials on registration, with passport.

FEES:

All swimmers will be charged a \$20.00 USD fee to enter the meet, regardless of the number of events they choose to enter through the online entry system.
