Duty to provide information pursuant to Article 13 GDPR

Personal data

The data collected is processed automatically in accordance with the GDPR. The legal basis for data processing is Art. 6 para. 1 lit. b GDPR implementation of pre-contractual measures, Art. 6 para. 1 lit. c GDPR fulfilment of legal obligations (e.g. Federal Sports Promotion Act, state sports promotion laws), Art. 6 para. 1 lit. a GDPR consent to the processing of personal data and Art. 6 para. 1 lit. f GDPR legitimate interests of the controller - namely public relations work and presentation of the activities of the controller in order to increase its level of awareness. The data will be transmitted to branch or member clubs, higher-level clubs and national and international associations of the association, or to third parties if this is necessary for the organisation of the sporting event in accordance with the invitation to tender. All data of ÖBSV members will be stored until the termination of membership plus any statutory retention periods. The data collected from non-members will be stored until the complete organisational final processing plus any statutory retention periods. There is no intention to process the collected data for the purpose of automated decision-making, including profiling (data analysis of behaviour, habits, preferences, etc.) (Art. 13 para. 2 lit. f GDPR).

Use of image and film recordings

By registering, participants consent to any production, publication, distribution, reproduction, use and exploitation of the photographs or other image, film and sound documents produced by them at an ÖBSV event by the provider (association, club), including attribution, provided that this does not affect any legitimate interests in their own image. This is certainly not the case if the participants are photographed or filmed as part of the above-mentioned event or if their names are mentioned under the respective photograph or on the list of participants. To this extent, the participants transfer the (utilisation) rights free of charge to the provider (association, club) or to the person producing these materials. This consent also applies in particular to the utilisation and use of these materials for (also commercial) advertising purposes of the provider and its member and branch associations, umbrella organisations, sponsors and supporters, of whatever kind and in whatever (image and sound) formats. This includes, for example, for the club's own homepage, for donation mailings, reports and advertisements in radio and print media, other printed materials (such as folders, invitations, etc.) as well as for reporting in social media and the ÖBSV newsletter.
